- (2) A non-refundable application fee of One Thousand Eastern Caribbean Dollars (EC\$1,000.00) is payable on submission of an application for a share registry licence.
- (3) The following documents (or copies) must be submitted in support of an application for a share registry licence:
 - i) Certificate of incorporation/continuance for the applicant,
 - ii) Memorandum and/or Articles of Association and/or Bylaws for the applicant,
 - iii) Audited financial statements for the applicant for the last three financial years. If the applicant is a start-up company, provide an audited opening balance sheet and projected financial statements for at least three years.
 - iv) An organisational chart for the applicant.
 - v) A manual detailing the applicant's internal operating systems and procedures (general operations manual).
 - vi) Resumes for the executive management team of the applicant (the resume should provide a summary of the officers' qualifications and experience).
