General Discussion and Analysis of Financial Condition

The main revenue source of the Company continued to be from the sale of electricity to customers in Saint Lucia.

The Company's financial performance fell short of budget due to lower sales, despite lower operating and administrative costs. This was driven by the measures implemented by the country in response to the global pandemic caused by the novel corona virus, COVID-19, which negatively affected business operations in the hotel, commercial and industrial sectors.

Compared to the prior year, financial performance for this period worsened as a result of lower sales and higher administrative costs, despite lower operating costs incurred due to the scale down in the Company's operations in response to the effects of the pandemic.

Liquidity and Capital Resources

Discussion of Liquidity and Capital Resources

(1) Liquidity

The Company continued to operate under debt covenants stipulated in Security Sharing Agreements (SSA) with its lenders which, among other provisions set the maximum level of debt that the Company is allowed to undertake.

The Company's working capital ratio at September 30, 2020 increased to 2.9 from 2.4 at December 31, 2019 as a result of the increase in current assets, driven by increases in trade receivables, income tax recoverable and inventory, as well as a decrease in current liabilities, due to reductions in trade and other payables and income tax payable.

There are no provisions contained in financial guarantees or commitments, debt or lease agreements or other arrangements, that could trigger a requirement for an early payment, additional collateral support, changes in terms, acceleration of maturity, or the creation of an additional financial obligation.

The Company continues to face challenges in the collection of cash from its customers, a ripple effect of the global pandemic associated with the novel corona virus, COVID-19. The country's largest contributor to GDP, the tourism industry, has been hit the hardest, directly affecting the hotel sector and filtering to the commercial and other sectors. The future is uncertain as the major markets; the United States, Canada and United Kingdom continue to grapple with this disease. Working capital management will be a key focus for the Company in the upcoming months.

The Company has not identified factors specific to it and its markets that it expects will affect its ability to raise short-term and long-term financing, guarantees of debt or other commitment to third parties, and written options on non-financial assets.

(2) Capital Resources

Capital expenditure for the nine months to September 2020 totaled EC\$15.8M, which was primarily upgrades to the T&D network and engine overhauls. The Company does not face any challenges raising financing to fund its capital projects.

Overview of Results of Operations

The analysis following is based on the consolidated results of St. Lucia Electricity Services Limited and its subsidiaries: LUCELEC Cap-Ins. Inc. and Energyze Holdings Inc.

Unit sales for the nine months ended September 30, 2020 totalled 250.8M kWhs, which was an 8.6% (23.6M kWhs) decline compared to 2019's total of 274.4M kWhs. This was driven by reductions in sales to the Commercial, Hotel, Industrial and Street Lights sectors of 5.1%, 37.7%, 2.5% and 5.5%, while sales to the Domestic sector increased by 5.3%.

The closure of the border in March 2020 in response to the pandemic resulted in the shutting down of most hotels, while the mandatory scale down of operations affected many businesses in the Commercial and Industrial sectors. Business activity has shown some signs of recovery and although more hotels have opened during the third quarter of 2020, sales to those sectors continue to be depressed. On the other hand, with the adoption of home schooling and working arrangements, domestic electricity consumption has increased This was further exacerbated by rising temperatures during the third quarter of the year resulting in the increased use of cooling devices by domestic customers.

Total revenue for the nine months ended September 30, 2020 (EC\$192.3M) was lower than the corresponding period of 2019 (EC\$234.2M) by 17.9% (EC\$41.9M) as a result of the decreases in the number of units sold as well as in the price of electricity.

Fuel costs for the current period (EC\$88.1M) were 25.0% (EC\$29.4M) lower than 2019's total (EC\$117.5M) due to lower fuel prices and fuel usage.

Transmission and distribution costs for the first nine months of 2020 (EC\$22.5M) were lower than the same period last year (EC\$32.2M) by 30.1% (EC\$9.7M). This variance was due to the reductions in depreciation (EC\$10.2M), payroll costs (EC\$0.8M) and motor vehicle costs (EC\$0.2M), despite the increases in T&D network maintenance costs (EC\$1.3M) and building maintenance costs (EC\$0.2M).

Generation costs for the period ended September 30, 2020 (EC\$18.1M) were lower than the same period in the previous year (EC\$20.5M) by 11.7% (EC\$2.4M). This was driven by decreases in engine maintenance (EC\$1.0M), solar farm maintenance costs (EC\$0.1M), payroll costs (EC\$0.8M), motor vehicle costs (EC\$0.1M) and building maintenance (EC\$0.4M).

Administrative expenditure for the first nine months of 2020 (EC\$26.8M) was greater than the same period last year (EC\$23.7M) by 13.1% (EC\$3.1M). This variance was mainly due to increases in the allowance for impairment of accounts receivable(EC\$5.8M), depreciation (EC\$0.7M), professional fees (EC\$0.2M) and insurance (EC\$0.1M), despite decreases in payroll and other employee costs (EC\$1.8M), training and conferences (EC\$0.4M), motor vehicle costs (EC\$0.3M), bank charges (EC\$0.2M), debt collection (EC\$0.3M), director-related expenses (EC\$0.1M), public relations and sponsorships (EC\$0.4M), security (EC\$0.1M) and meter reading costs (EC\$0.1M).

The fair value gain on FVTPL financial assets for the current period (EC\$0.5M) was lower than the same period last year (EC\$2.8M) by EC\$2.3M due to changes in the market value of investments.

The profit before tax for the nine months ended September 30, 2020 (EC\$34.1M) was lower than the same period last year (EC\$39.9M) by 14.5% (EC\$5.8M).

Profit after tax for the first nine months of 2020 (EC\$24.7M) was 16.6% (EC\$4.9M) lower than the corresponding period last year (EC\$29.6M).

3. Disclosure about Risk Factors.

- 1. The Company faces the risk of disruption in its utility operations, adverse financial results, poor liquidity, and reduction in workforce productivity during the COVID-19 pandemic. This is due to the decline in electricity demand from the closure of the hotels, restrictions on non-essential businesses, the need to observe social distancing particular at the work place and from the possible shut down of facilities in an attempt to contain the spread of COVID-19. Sales forecasts indicate that the Company will not achieve its revenue and profit targets this year. In response, the Company has taken proactive steps to defer capital investments and reduce cost of operations as much as possible without compromising service quality in the short term. The Company also faces the risk of disruption to its supply chain and may experience delays in the fulfillment of orders for critical parts required for maintenance and restoration works.
- 2. The Company had identified certain risks in the process of preparing for the new regulatory framework. To mitigate this risk, the Company established a Regulatory Reform Team to spearhead the Company's involvement in the regulatory reform process. This risk is considered stable.
- 3. A significant portion of the total electricity price to consumers is the cost of fuel. The Company has identified this, as well as the volatility of fuel prices on the world market, to be significant risks. The Company continues to use fuel price hedging to help mitigate the risk of volatility in fuel prices. Currently supply and demand factors are working to stabilize fuel prices and the market does not anticipate any significant movement in prices over the next 12 months.
- 4. The inability to meet consumer demand for electricity is considered a major risk to the Company. This can be brought on by either an unforeseen increase in the demand for power or the loss of generators or substations. The Company employs a robust preventative maintenance programme to mitigate the risk of unplanned asset downtime. Uncertainty regarding the implementation of investment projects in the private and public sector, contributes significantly to the assessment of this risk. This risk is considered low to moderate. As the existing generation assets near the end of their useful lives, and the uncertainty of future demand increases, this risk will increase.

- 5. The annual hurricane season between June and November remains a constant risk factor. As far as practicable the Company continues to design its systems to minimize the impact from hurricanes. The Company continues to maintain a robust disaster recovery plan in the event of extensive damage resulting from a weather system. The risk of Loss of T&D assets and resulting impact on the reliability of the power supply is increasing given the intensity of storms affecting the region. This risk is considered to be moderate but increasing.
- 6. Obtaining insurance coverage for the Transmission & Distribution (T&D) plant on the market at a cost-effective rate continues to be a challenge. As such, the Company established a Self-Insurance Fund as a vehicle to mitigate losses in the event of catastrophic events. As at September 30, 2020, the Fund balance was EC\$47.6M. The Company has access to a standby credit facility of EC\$10.0M to meet any emergency asset restoration costs should the need arise. The Net Book Value of the T&D assets was EC\$146.6M at the end of September 2020. Although the Company's contribution to the Self Insurance Fund is deemed to be adequate, the fund would not be sufficient to cover a total loss of its T&D infrastructure. This risk is considered high. The Company continues to explore options for mitigating against the impact of such a catastrophic event.
- 7. With a new regulatory framework, the threat of loss of sales due to the introduction of renewables and competition for generation is likely; however, at the current rate of growth of renewables, this threat appears to be low. Although this risk is considered low, uncertain events such as the price of fuel, the cost of renewable technology, and the tariff regime, can increase the risk within a short period.
- 8. Receivables management remained a priority for the Company. All accounts continue to be monitored on an on-going basis to manage this risk. Credit risk is considered to be high at this time.
- 9. The Company utilizes Return on Equity as one of the measures of its performance. As shareholders' equity increases and profit levels remain fairly constant, the Company is faced with the risk of continued diminishing Return on Equity. The Company will continue exploring cost optimization opportunities that are the output of a comprehensive process analysis, as a means of mitigating this risk. This risk is considered to be increasing in light of the current economic environment.
- 10. System Losses, specifically due to electricity theft, continue to be a concern for the Company, given the implications for unrecognized revenues and ultimately reduced shareholder returns. This risk is stable and does not show any sign of worsening.
- 11. The fallout from industrial action can affect the Company's reputation and by extension that of the country, with regards to foreign direct investment. Employee engagement and staff relations continue to be a priority in the Company's annual work plan. Until all union negotiations and outstanding issues are satisfactorily concluded, the risk of industrial action continues to be high.
