As at March 31, 2019, the Bank's portfolio of liquid assets amounted at \$169.15 million. When compared to the total on record at December 31, 2018, liquid assets increased by \$24.98 million. The increase is attributable to the increase in the ECCB Reserves by \$10.21 million and increase in short term deposits \$6.22 million. Liquid assets refer to those items with a tenure not exceeding three (3) months. The main components of the liquid asset portfolio for the period under review are: correspondent accounts, short term deposits with regional and international financial institutions as well as short-term
