General Discussion and Analysis of Financial Condition

As at December 31, 2017, The Bank of Nevis Ltd (The Bank) recorded total assets in the amount of \$579.90 million. This amount represents a net decline of \$10.6 million from the total reported at September 30, 2017. The net decrease during the quarter under review is primarily attributed to the utilization of liquid funds to satisfy customer withdrawal and drawdown requests via the deposits as well as the loans and advances portfolio.

When compared to the audited position at June 30, 2017, total assets has increased by a marginal \$1.7 million or 0.3%.

Total loans and advances increased by \$9.6 million during the quarter, bringing the total at the end of the reporting period to \$226.5 million. The net increase over the three month period is as a result of increased credit which was extended to the local government.

At December 31, 2017, total deposits held on behalf of customers stood at \$335.9 million, a net decrease of \$9.1 million when compared to the amount which was recorded at September 30, 2017. The US Dollar Demand and US Dollar Savings categories are the most significant contributors to the quarter's decrease.

Discussion of Liquidity and Capital Resources

The Bank's liquidity remained stable throughout the three month period ending December 31, 2017. At the end of the reporting period, the Bank's portfolio of liquid assets was recorded at EC\$121.6 million or 21.0% of the total asset base. Liquid assets comprise primarily of correspondent accounts, short term deposits with regional and international financial institutions as well as short-term treasury bill investments via local and regional government bodies. The loans to deposit ratio at December 31, 2017 was 67.44%.

The Bank's liquidity position is constantly monitored, and the executive management meets on a weekly basis to discuss the position as well as recent trends and projections.

Overview of Results of Operations

For the three month period ending December 31, 2017, The Bank recorded net profits in the amount of \$3.0 million. When compared to the cumulative earnings of the previous year, this amount represents a net improvement of \$2.0 million.

During the quarter under review, a total of \$4.4 in interest income was earned. Of this total, \$3.4 million was contributed via the loans and advances portfolio.

Total interest expense for the three months ending December 31, 2017 is \$1.7 million, to increase the cumulative total for the financial year-to-date to \$3.5 million. When compared to the similar performance in the prior year total interest expense declined by \$321,974 or 8.5%. The comparative net decline is mainly attributed to the continued reduction of interest rates offered on fixed deposit accounts at maturity.

Total operating income for the second quarter of the financial year was reported at \$7.1 million, a net increase of \$3.5 million over the September 30, 2017 total. Notwithstanding the net performance for the quarter just ended, operating income declined by \$2.0 million or 22.2% in comparison to the similar performance one year ago.

A total of \$2.9 million in operating expenses was recorded during the second quarter of the financial year. The resulting total at December 31, 2017 stood at \$5.2 million. The main component of expenses within this category is the general and administrative expense category which contributed \$4.04 million or 77.7% of the cumulative total.

The Bank is faced with diverse risks in the conduct of its daily operations. Risk is defined as the possibility of losses of profits foregone, which may be caused by internal or external factors. Some of the major risks facing the Bank are outlined below.

Credit Risk:
The most predominant risk factor within the Bank's environment is Credit Risk. It is the risk of incurring a financial loss in the event that any of the Bank's customers or counterparties fails to fulfill their contractual obligations to the Bank. The Bank's credit risk arises mainly from the loans and advances portfolio which constituted 39.1% of the Banks total assets at December 31, 2017. The Bank is also exposed to other credit risks arising from investments in debt securities and other exposures from its trading activities.

Foreign Exchange Risk:
Also affecting the Bank is the effects of fluctuations in the prevailing foreign currency exchange rates (foreign exchange risk). The majority of the Bank's assets and liabilities are held in Eastern Caribbean dollars which is the local currency. Most of the assets in foreign currencies are held in United States dollars. The exchange rate of the Eastern Caribbean dollar to the United States dollar has been formally pegged at EC\$2.70 = US\$1.00 since 1976. Assets and liabilities are also held in Euro, Pound Sterling, Canadian and Barbados currencies, the exposure to which is not material to the Bank's financial position.

Market Risk
Market risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate due to changes in market prices. This exposure arises via select assets within the investment portfolio, which at December 31, 2017 amounted to EC\$73.75 million or 12.48% of the total asset base. The market risks arising from the investment portfolio are continuously monitored by the Investment and Risk Management Committees and by Management.

Liquidity Risk
